DELAWARE RIVER SOLAR:

DRS was given a chance to speak. Dan Compitello introduced himself, Henry Zawodzinski, they legal council ad Kristin Jacobs. He spoke about why he feels (referring to the written communication) the impact of the EFA 17 a & c should be a small impact.

Henry Zawodzinski stated that it is consistent with land use regulations because solar is allowed by the Village.

The applicant was asked again, if they reduced the size of the project, would it still be profitable. Dan Compitello stated that they have already reduced the size per the Boards request, by moving the location of some of the panels and removing some panels. They were able to do this and make up what was removed with newer updated panels the were more efficient.

The applicant was asked what the Tax Revenue plan was and if it was 5 years. Dan Compitello answered they have a 15 year pilot program.

The applicant was asked if it would only benefit those in the community who sign up to use this power and Dan replied that the taxes go to the Village so the entire community will benefit.

The Board was going through the Facts and Finding, with all for variance requests as a whole. The Applicant and their council requested that each of the four variances be done individually.

After much discussion, the applicant asked to hold going through this until the January 19, 2023 meeting as they filled the application out as they were instructed, but feel each request should be separately. 1 Northern variance, 1 Front Side variance and 2 Southern variances.
